- The ISO Fire Protection Rating is used to help **calculate the overall cost of insurance for your home or business** in Bernards Township.
- LCFC's 70 volunteers – all with professional, trade and academic full-time careers of their own - are **continuously trained and prepared** to provide **structure fire suppression and personnel rescue**, motor vehicle fire suppression and patient extrication from crashes, gas leaks and carbon monoxide and hazmat incidents.
- The fire company membership is **comprised of your friends and neighbors, men and women, who are inspired to volunteer their personal time and give back to the Community**.
- These are the same services that our **all-volunteer** members have provided to our community **for over 104 years** to the **entire central and southern sections of Bernards Township**.
